CURRENT RESEARCH

- Ethics Evolving: House Ethics Investigations and the Changing Content of Unethical Political Behavior, 1798-2004 (Book Manuscript): An examination of partisanship in the ethics process and of the content of ethics charges. The book illuminates the ways that the definition of "unethical" political behavior has evolved over time, exhibiting both change and continuity. I present a new classification scheme of ethics cases. I also argue that ethics investigations both reflect and contribute to broader historical processes and political tensions, for example over slavery and industrialization. Finally, the book will examine the current ethics processes in the House, including the operation of an "independent" ethics commission. Three chapters completed (90 pages).

BOOK PUBLICATIONS

Shadowlands of Conduct: Ethics and State Politics (Georgetown University Press, 2005)

Using quantitative analysis, case studies and historical research, this book examines several questions: Why do legislators enact ethics or conflict of interest laws? Why do states vary in the timing and the stringency of their legislative ethics laws? What are the limits of ethics laws and enforcement? The book shows how enactment of ethics laws is facilitated primarily by scandals and to a lesser extent by the actions of neighboring states. While actors outside legislatures were key to the laws' passage, legislators did not abdicate their role in the design of ethics regulation. The enactment of legislative ethics laws accommodated lawmakers' economic and political interests. The book thus highlights the gaps and loopholes in even the "strongest" ethics laws and provides a cautionary tale for political reformers.
